A1. Please note that our General Specification will supersede any other request for insurance therefore, five million dollars will suffice as per General Specifications terms 6.8.01 Liability Insurance.

Q2. The roofing material specs are limited to SOPREMA and three others that we don't purchase materials from (Johns Manville, Siplast, and Tradesman). We request that equivalent materials to Soprema be approved from IKO and FRANSYL who are active suppliers to the New Brunswick roofing industry.
