# M.C.R.T. 2020 highlights

iMCRT received a call dispatched from Police for an on-site assessment. Upon arrival the homeless individual reported to have a history of mental illness and felt that homelessness was contributing to his overall mental decline. iMCRT Nursing staff provided an on-site mental health assessment. No immediate safety concerns were identified. Following the assessment, the individual was agreeable to problem solving strategies by connecting with community Addiction & Mental Health Services as well as re-engaging with Outflow Men's Shelter for immediate support.

# M.C.R.T. 2020 highlights

iMCRT received a call dispatched from Police for an on-site assessment. Upon
on-site arrival the individual was witnessed to be tearful, avoiding eye contact
while their friend was expressing fears that self-harm was a possibility. Nursing
staff from iMCRT provided an on-site mental health assessment (exploring
mood, safety risks, medication use etc..). The individual was responsive to this
dialogue and began discussing various options to achieve and maintain
positive motivation in her life (social engagement, hobbies she enjoyed but
had not engaged in for months, physical exercise etc...) among other things.
