## 8.02 SJBPC Unaudited Financial Results as of March 31, 2021

Mr. Craig Lavigne, Asst. Comptroller Finance stated that the purpose of the report was to provide a budget update on the unaudited financial position of the Saint John Board of Police Commissioner Operating Budget as of March 31, 2021.

He stated that the Commission's preliminary March 31, 2021 financial results are anticipated to be \$6,940 (28.34%) - positive variance. Expenditures are underbudget by \$7,613 and wages and benefits are over budget by (\$673).

A Police Commission Statement of Operations was attached to the report.

On motion of Commissioner Norton Seconded by Vice Chair Jones

RESOLVED, that the unaudited financial position report for the Saint John Board of Police Commissioners' Operating Budget as of March 31, 2021, be received and filed. (O2104-04)

# 8.03 SJPF Unaudited Financial Results as of March 31, 2021

Mr. Craig Lavigne, Asst. Comptroller Finance stated that the purpose of the report was to provide a budget update on the unaudited financial position of the Saint John Police Force's Operating Budget as of March 31, 2021.

The Force's preliminary March 31, 2021 financial results are anticipated to be \$296,561 - (5.39%) positive variance. Overall wages and benefits are underbudget and can be attributed to savings due to overtime and other personnel changes. Other goods and services were slightly underbudget due to timing and a reduction in education and training due to COVID-19. He stated that estimates for year-end projections are extremely difficult to predict this early in the year and are subject to change.

A Saint John Police Force Statement of Operations for the period ended March 31, 2021 was attached to the report.

## 8.04 PSCC Unaudited Financial Results as of March 31, 2021

Mr. Craig Lavigne, Asst. Comptroller Finance stated that the purpose of the report was to provide a budget update on the unaudited financial position of the Public Safety Communication Centre's (PSCC) Operating Budget as of March 31, 2021.

The PSCC's preliminary March 31, 2021 financial results are anticipated to be (\$57,419) (19.96%) negative variance. Expenditures as of March 31<sup>st</sup> are underbudget by \$9,031 and wages and benefits are over budget by (\$44,924). Mr. Lavigne stated that Overtime continues to be a challenge with the impacts of the Cyber attack still being felt in 2021, as well as continued staffing vacancies. Vice Chair Jones mentioned that this is a significant gap on a \$1.3 million budget and that they need to reverse the trend. Mr. Lavigne stated that there are currently two new operators in training and if successful, these operators will alleviate some of the staffing pressures.

A Public Safety Communications Centre Statement of Operations for the period ended March 31, 2021 was included in the report.

On motion of Vice Chair Jones Seconded by Commissioner Sullivan

RESOLVED, that the unaudited financial position report for the Public Safety Communication Centre's Operating Budget as of March 31, 2021, be received and filed. (O2104-06)

Question being taken, the motion was carried.

# 8.05 City of Saint John Website - Update

Commissioner Sullivan mentioned that the City of Saint John now has a beautiful, multifunctional website up and running, and he would like to see the Saint John Board of Police Commissioners (SJBPC) take advantage of that and become more accessible to the public. He also mentioned that he would like to see additional documents such as the Saint John Police Force budget, policies, agendas etc. posted the same as other departments (i.e., Council), and that they could also look at posting previous recordings of the meetings and have the option to watch the current Open Session meeting. He

stated that this would require more conversations with the Information Technology (IT) department, but feels it would be beneficial as currently users have to navigate through several menus on the city's website to find information about the SJBPC.

Chair Keyes stated that he is hopeful that more information can be added to the website once the City fully recovers from the Cyber-attack.
