Please note the suggested stockpile location may be altered throughout construction. However, upon completion of the contract, the contractor will relocate all materials to the stockpile location indicated. For clarity the stockpile materials will be placed on the southern edge of the site as noted.

Decking found in vacant vendor space located between Saint John Ale House and McGill's is to be removed by contractor.

Please note all contractor fencing will be temporary and removed at the end of the project. Gates are to be included as required to facilitate the work. Gates indicated are to be wide enough to facilitate service vehicles. Location of fencing near entrance of market square and saint john ale house to facilitate emergency access points and may need to be altered to match contractors suggested workflow. Cost is to be carried under Section 4.5 Item E-1 Miscellaneous lump sum.

Clarification: The contractor shall not block emergency exits of market square. Ensure safety measures are put into place during work. The contractor will employ the use of security fencing and gates to mitigate risk. It is understood the contractor will accommodate emergency access as required by client. Coordination meeting to be held once contractor schedule of works submitted.

<u>Clarification 1</u>: This contractor shall allow for the disconnection and removal all electrical associated with the existing onsite electrical shed, as well as coordination with Saint John Energy for service entrance disconnection. This contractor shall allow for the removal of the shed (after electrical is disconnected) from the property and relocated as required by the shed owner.

<u>Question 2</u>: Clarification regarding the scope of work for existing post lighting:

<u>Clarification 2</u>: All existing post lighting within the boundaries of the demolition scope within contract limit shall be disconnected and removed. All post lighting outside of the demolition scope boundaries shall remain; this contractor to allow for the re-instatement of electrical feeders to existing post lighting to remain, refeed existing post lighting from market square electrical room.
