Chief Bruce went through the report and stated that there was a total of 55,243 calls for service last year, compared to 52,685 the previous year. Officers generated nearly 9,100 incident reports and he highlighted where the force is seeing some of those increases. He mentioned that property crimes — including thefts, break and enters and mischief — jumped by 30 per cent to 2,298, while calls involving violent crime were up by about two per cent to 843. There were also 1,758 calls relating to mental health, an increase of nearly eight per cent from the previous year and he mentioned that some of the increases relate to the ongoing COVID-19 pandemic. There were 102 files involving impaired driving which is up from 72 the year before, and the total number of tickets issued dropped by nearly 20 per cent to 1,083.

#### 9. New Business

### Parking Ban Towing with By-Law Enforcement Officers

Chair Jones thanked Chief Bruce for their involvement regarding the Amendment to the Traffic By-law Number MV-10.1 as the Saint John Police Force has played an integral role during both North-East-West (NEW) and the South-Central Peninsula (SCP) overnight parking bans.

Chief Bruce stated that historically, only the Saint John Police Force has had authority to permit a vehicle to be towed. Given the Police Force's need to balance attention to exercising their authority during called bans versus their responsibility for overall public safety, their resources are sometimes a limitation to how many vehicles can be towed during a called parking ban.

The Saint John Police Force, City Staff in Public Works, Parking, and the General Counsel's Office have collaborated in developing an alternative approach. With the endorsement of Common Council of the by-law amendment, and future designations of by-law enforcement officers, Traffic By-Law Enforcement Officers would be granted authority to cause vehicles to be towed during called SCP and NEW overnight parking bans. This would increase the resources available to authorize towing and allow the Saint John Police Force to focus on other public safety matters.

### Strategic Plan

Mr. Jones stated that the board has been reviewing the final draft of the Strategic Plan and there is still some fine-tuning, but it is roughly 90-95 percent complete. They are working on a communications plan and will be releasing more details in the coming weeks.

At this time the media were invited to ask questions of the board.
