8.2 SJBPC Unaudited Financial Results as of April 30, 2022

Craig Lavigne, Financial Controller reported that the preliminary unaudited operating budget results show a deficit of (\$15,525) year to date. Overall wages and benefits are over budget by (\$1,512) and goods and services are over budget by (\$13,913) year to date.

Professional fees and purchases services are over budget due to costs associated with finalizing the Collective agreement and various service procured year to date. It is anticipated that these budget lines will be one budget for year end.

8.3 SJPF Unaudited Financial Results as of April 30, 2022

Craig Lavigne, Financial Controller reported that the Force's preliminary unaudited April 30, 2022, operating budget results show a surplus of \$219,131. Overall wages and benefits are under budget by \$570,116 and can be attributed to vacancies, retirements, and wage recoveries. Goods and services are over budget by (\$350,985) due to a variety of factors.

Insurance deductible is overbudget due to more claims than anticipated. Professional services variance is due to a larger number of legal services obtained to date relating to factors such as finishing the collective agreement for the Police association. Other purchased services and repairs and maintenance are related to timing of goods and service received year to date.

The largest year to date variance is for vehicle purchases. The Police have received several vehicles to date this year and have funding available in their vehicle reserves. Transfers to and from reserves are done annually and the funding to cover the cost of vehicles will be completed before the end of the year with a resolution from the board.

Overall year end forecast shows the force being on budget. A few areas of concern that will need to be mitigated is the higher insurance deductible costs, any unanticipated legal costs and higher fuel cost. There will still be a lot of variability around the overall cost of goods and services due to raising inflation which his already having a significant impact on the city.

The use of forecasting allows management to best decide how to utilize funds based on current results, along with known upcoming expenditures and budget variance to guide decision making to ensure financial management of the forces annual operating budget.

Revenue is anticipated to fall short of budget due to earlier than expected Secondment that was budgeted for 2022.

8.4 PSCC Unaudited Financial Results as of April 30, 2022

Craig Lavigne, Financial Controller reported that the Public Safety Communication Centre's (PSCC) preliminary unaudited April 30, 2022, operating budget show a surplus of \$7,294 year to date. Overall wages and benefits are under budget by \$11,808 and goods and services are over budget by (\$4,514).

Overall, the goal for the year will be to continue to focus on getting the Centre to 100% staffing level which will keep salaries and benefits on budget for the year. Revenue is anticipated to be slightly underbudget for the year.

8.6 <u>Purchase of New Vehicles</u>

The Saint John Police Force as part of its fleet replacement requirements needs to replace six patrol vehicles in 2023. Four of the vehicles being replace will surpass end of life in 2023 and two were damaged beyond repair. It is critical to replace vehicles to ensure operational needs are met and to minimize excessive maintenance cost.

The base cost for each vehicle is \$57,055.50 and the anticipated cost for fit up is \$15,000 per vehicle for a total cost of \$432,333 (plus applicable HST).

The cost for the vehicles will be funded from the Police vehicle reserves which as the funding available to cover the cost. The vehicles are not anticipated to arrive until 2023 based on current projections.

The purchase of these vehicles align with the Forces fleet strategy, meets the operational needs of the Force and Common Council's priority of Green. The City's procurement department has reviewed the vehicle request and facilitated the pricing and procurement of the vehicles.

Moved by Vice Chair Dean, seconded by Commissioner Bryant:

RESOLVED, that the Saint John Board of Police Commissioners approve the purchase of six (6) Ford Explorer Hybrid AWD Police Interceptors at a tender price of \$432,333 (plus applicable HST) and authorize the City of Saint John to issue a purchase order to Downey Ford. (O2206-10)
