- Q2. Would firm which would be awarded this contract prevented from supplying, delivering and implementing the new ERP?
- A2. Please refer to answer A1.
- Q3. How long would the consulting engagement contract be set? 6-month engagement?
- A3. Proponents must submit timelines that they believe are reasonable for efficiently and successfully accomplishing all requirements of the RFP.
- Q4: Would the City consider a 2-week extension to the due date?
- A4. Yes. Please note that the closing date has been extended to Thursday, September 22, 2022, 4:00:00 pm, ADT. As such, please note that the deadline for enquiries has been extended to Tuesday, September 13, 2022, 4:00 pm, ADT and the deadline for addenda to Thursday, September 15, 2022, 4:00 pm, ADT.
- Q5. Would the City consider allowing electronic submission of the proposal?
- A5. No, proposals are to be submitted as per the RFP instructions.

- A8. See answer A7 above.
- Q9. How is this RFP different from the one issued in April (2022-092201P)?
- A9. This RFP is solely focused on Readiness and Requirements.
- Q10. On NBON, 2022-092201P shows as not being awarded. Do you intend to award this?
- A10. No, RFP no. 2022-092201P has been cancelled.
- Q11. What are the City's next planned steps after the assessment delivery? We assume you will issue an RFP for an ERP implementation (based on the assessment done in this project).
- A11. The results of the Readiness Assessment and Needs Analysis will affect the City's next steps, including timing, so we cannot give timelines for the RFP implementation now.
- Q12. Can we electronically sign the proposal (verified Docu-sign), or do you need actual "pen on paper"?
- A12. Electronic signature is acceptable.
