ADDITION TO THE SPECIFICATIONS

Division 2 – Submission of Tender

As a result of the COVID-19 pandemic, the City of Saint John is implementing adjustments to the tender submission procedure as follows:

Section 2.6.01 Location of Tender Box for the Submission of Tender

175 Rothesay Avenue, Saint John, New Brunswick

The tender box will be available at the main building entrance for submission of tenders by the Tenderer between the hours of 9:30 am and 2:30 pm only on the above tender closing date. Tenderers shall maintain physical distancing from others when depositing their tender in the tender box.

There will not be a public tender opening. Registered Bidders will receive an email invitation to view the Tender Opening using Microsoft Teams software. Email invitations will be sent to the address provided on the Official Bidder's List. The Tender Opening Committee will conduct the evaluation of the tenders and Compliant tenders will be included in the summary of bids on the City's Tenders & Proposals website within 1 business day following the tender closing.

CLARIFICATIONS

Question – Do you have a spec/pigment requirement for the red and “white” concrete?

Answer – “White” concrete is intended to be standard City of Saint John Specification concrete with no added colour. “Red” concrete please use the following colour and mixture: Concentrated colour pigment RG-2827 Red, as manufactured by Interstar (1-800-567-1857), or approved equal.

Question – Do you have any information on the bell to be relocated ie. Weight, dimensions, lifting points, is the bell anchored to the pad? Photos?

Answer – Please see attached addendum sketch for dimensions (all in mm), see attached photos for reference. We do not have the exact weight. The bell is not anchored to the pad.

Question – The supplier for the benches (Maglin) are telling me the Pixel benches are not available with a top of Wood Grain HDPE Cedar colour as specified. Could you have the consultant verify? Also the Pixel style benches specified do not match the benches that are installed in the previous phase, was the intention to match the benches?

Answer – Please replace “Wood Grain HDPE Cedar colour” with “Orange-peel texture HDPE in three (3) colour options (Brown/Green/Orange), layout and colour arrangement to be completed and approved by consultant prior to purchase. All bases are to be Turquoise in colour. Please install Pixel style bench as per the contract documents.

Note: Signed copy of the addendum **must** be enclosed in the tender documents, according to the Instructions to Tenderers and Tendering Procedures in Division 2 of the Contract Specifications.
