#### **Questions and Answers**

- Q1. Do have you a have a schedule of hours worked and number of persons on duty -I can see the requirement for 24/7 cover, but how many guards do you need on duty at a time?
- A1. We require one individual to be on-site at all times for security purposes for their shift. The specific time slots that need coverage are as follows:
  - Monday through Friday: Coverage is required from 4:00 PM to 8:00 AM the following day, amounting to a 16-hour shift. (Sheriffs are attending during the day, and they are the ones who carry out the bulk of the activities related to the facility and the managements of its inhabitants.)
  - Weekends: Full 24-hour coverage is needed for each day.
- Q2. Do you have a pricing table layout you want us to complete (appendix B)?
- A2. Proponents are welcome to append any necessary information to Appendix B.
- Q3. Is there a particular day you want us to attend for site visits? Who should we contact to arrange this?
- A3. Proponents may contact Frank Szalai by phone at (506) 648-4984 to arrange for a site visit.
- Q4. Is there any requirement for guards to be hands on with a detainee? If so is there a established level of training for use of force or conflict resolution?
- A4. The contractor is expected to remain within the designated 'bubble', the office for the guards, with no direct physical interaction or handling of detainees. Therefore, it is sufficient for candidates to possess only a theoretical level of understanding in the use of force.
