Please find below some clarification points/questions and answers.

- Q1. Drawing E-1, General Note 4 Can you confirm that this note applies to ceiling mounted occupancy sensors only?
- A1. Note 4 applies to all sensors.
- Q2. What are the hours of operation Drawing E-1, General Note 6 Are we to assume that all fixtures being retrofitted do not already have a means of quick disconnect?
- A2. That is correct, we are unsure if they are equipped with disconnects presently. Price as though there are none presently.
- Q3. Drawing E-1, General Note 13 Can you confirm that SJE will not need to be involved when shutting down the facility (contractor can shut down using facility breakers)? Can you confirm there are no costs associated with the involvement of the fire chief?
- A3. SJE has no need to be involved, we simply want to simulate a power outage to ensure the luminaires on emergency power turn on. Fire Chief does not need to get involved, this was a typo copied from another project involving Fire Stations.
- Q4. Drawing E-4 Can you confirm that there is no work associated with the two type "V" fixtures shown on the exterior wall outside of the vehicle impound (room 1112)?
- A4. All exterior luminaires are existing LED type, no work required for the two Type V luminaires shown.
- Q5. Drawing E-4 Can you advise on the requirements of fixture type "P1" shown just inside the door of forensics (room 1107)?
- A5. Type P1 is a typo, please provide a new Type 'C1' downlight.
