### Please find below questions and responses.

- Q1. Pg. 29 WWTP /WWPS's What are the expectations to consider when providing a cost? I.e. what type of equipment and service requirements should be included in this cost per inspection?
- A1. Time and material, and typical equipment would be just air handling units and exhaust fans.
- Q2. Appendix F pg. 63; are annual inspection / condition assessment reports required for each piece of equipment per site? Or just the gas heating equipment noted in the Appendix F samples? will the City accept suggestions of similar vendor reports or is the selected vendor to use the provided forms?
- A2. Required for each piece of equipment please, we will accept similar vendor reports.
- Q3. DDC / BAS (building automation controls system) requirements on Delta Controls at SJ Transit?
- A3. Building automation controls system is not included.
- Q4. Upon start-up of refrigeration plants Does the City employ staff to throttle the suction valves, or is it expected to be completed by the contractor?
- A4. No, this is to be completed by the contractor.
- Q5. Appendix B, Pricing, SJ Transit. Pg. 31,32: The RFP requests "cost per inspection", however column "E" details "2x inspections per year". Does the City want a cost for the 2x inspections annually—or the cost per 1 inspection as needed? Similar with the Gas Detection pricing on pg 33 where some are once per year and some are twice per year
- A5. Cost per inspection.
