### TO DIVISION 3 – PARTICULAR SPECIFICATIONS

Page 3-19, replace Clause 3.1.30.9 with the following:

### 3.1.30.9 Measurement For Payment – Dominion Park SLS Civil

The quantity to be measured for payment shall be by the lump sum. This includes the supply and transportation of all labour, materials and equipment, excavation and backfilling for the foundations, trucking material off site and stockpiling of material for re-use, shoring, dewatering trenches and excavations, dewatering of sanitary wastewater including the existing forcemain during tie-in, crushed rock or crushed gravel and pit run gravel for backfilling and under concrete, compaction, adjustments, thrust blocks, site work, flexible sealant, clean-up, and all work incidental thereto, all as specified or as shown on the drawings or as laid out by the Consultant.

The lump sum price for station construction shall also include the modification to the existing wet well consisting of the supply and transportation of all labour, equipment and material, excavation, trucking material off site and stockpiling of material for re-use, backfilling, shoring, dewatering, granular bedding material, compaction, new pre-cast concrete wet well cover and sections as required, modification of existing wet well benching to allow installation of new pumps, access hatch(s), frame and cover, gaskets, padlocks, insulation, flexible sealant, core drilling, pipe seal, leakage testing, adjustments, clean-up and all work incidental thereto, all as specified or as shown on the drawings or as laid out by the Consultant.

Page 3-19, add Clause 3.1.30.10:

### 3.1.30.10 Measurement For Payment - Dominion Park SLS Structural

The quantity to be measured for payment shall be by the lump sum. This includes the supply and transportation of all labour, materials and equipment, concrete form work, reinforced concrete work, concrete, foundation, lean concrete infill under foundations, rigid foundation wall insulation, installation of pipe penetration sleeves, fibreglass enclosure including all required insulation, strapping, doors and hardware, metal cladding and accessories, outside finishes, various exterior metal work stairs, railing and grating, paint, clean-up, and all work incidental thereto, all as specified or as shown on the drawings or as laid out by the Consultant.
