Division 2 – Instruction to Tenderers and Tendering Procedures

The City of Saint John is implementing adjustments to the tender submission procedure as follows:

- Revised Deadline for Issuing Addenda: Thursday, February 20, 2025.
- Revised Tender Closing: 2:30:00 pm AST, Wednesday, February 26, 2025

Section 2.6.01 Location of Tender Box for the Submission of Tender

175 Rothesay Avenue, Saint John, New Brunswick

The tender box will be available at the main building entrance for submission of tenders by the Tenderer between the hours of 9:30 am and 2:30:00 pm only on the above tender closing date.

There will not be a public tender opening. Registered Bidders will receive an email invitation to view the Tender Opening using Microsoft Teams software. Email invitations will be sent to the address provided on the Official Bidder’s List. The Tender Opening Committee will conduct the evaluation of the tenders and Compliant tenders will be included in the summary of bids on the City’s Tenders & Proposals website within 1 business day following the tender closing.

Questions and Responses:

Q1: Is the Irondome detectable warning surface from ADA Solutions an acceptable product?

A1: The Irondome detectable warning surface from ADA Solutions is an acceptable product.

Q2: Is the Spectra Niteglow Safety Nosing by Wooster Products Inc. an acceptable alternative to the Ecoglo Non-Photoluminescent Cast In Place Stair Nosings?

A2: The Spectra Niteglow Safety Nosing by Wooster Products Inc. is not an acceptable alternative to the Ecoglo Non-Photoluminescent Cast In Place Stair Nosings. Alternatives from the same supplier may be considered in the specified Yellow colour.

Q3: Our electrician has informed us that the lighting on this project is from a supplier in the United States. Given the recent concerns with importing materials from the US, is there an alternative in Canada which is approved?

A3: Item 15 of the electrical specifications (Drawing E1) allows for the submission of product alternates for approval. Requests for product alternates must be received prior to the Deadline for Enquiries.

Q4: Given that Monday, February 17th is a holiday, would it be possible to extend the closing date for this project by at least two days?

A4: See above revised schedule for the tender process.

Note: Signed copy of the addendum **must** be enclosed in the tender documents, according to the Instructions to Tenderers and Tendering Procedures in Division 2 of the Contract Specifications.
