Email invitations will be sent to the address provided on the Official Bidder's List. The Tender Opening Committee will conduct the evaluation of the tenders and Compliant tenders will be included in the summary of bids on the City's Tenders & Proposals website within 1 business day following the tender closing.

### ADJUSTMENTS TO DIVISION 4 - FORM OF TENDER

Please see the following response to questions received:

Q1: Street Signage - Would you mind providing the spec for the signs?

A1: Please refer to the Tender Documents, Section 3, Appendix B.

Q2: Are the majority of the storm services just getting capped off at the property line other than the lateral at 43 where there would be an actual connection at the property line. Just wondering if you know if there are existing draintile on the buildings we need to tie into / find at the property line.

A2: Records indicate there are 2 existing storm laterals that the contractor would need to connect to. There are 2 proposed storm laterals to be installed and capped. Locations will be confirmed in the field during construction.

**Q3**: Can the city review the asphalt quantities and adjust if need to reflect the actual scope of work more accurately?

A3: Please refer to Sheet 14 of 17 (Addendum #1).

**Q4:** There is a note on the drawings that mentions all existing capped laterals to be removed from the roadway unless otherwise directed by the engineer. I know the specifications mention that pipe removal outside normal limits will be paid under common excavation and imported gravel. I just want to confirm that removing the capped laterals will be paid through common excavation along with other pipe removal outside the pipe trenches.

A4: Please refer to the Tender Documents, Section 3.1.18 Excavation Outside Normal Trench Limits.
