Division 2 – Instructions to Tenderers and Tendering Procedures

The City of Saint John is implementing adjustments to the tender submission procedure as follows:

Section 2.6.01 Location of Tender Box for the Submission of Tender

175 Rothesay Avenue, Saint John, New Brunswick

The tender box will be available at the main building entrance for submission of tenders by the Tenderer between the hours of 9:30 am and 2:30:00 pm only on the above tender closing date.

There will not be a public tender opening. Registered Bidders will receive an email invitation to view the Tender Opening using Microsoft Teams software. Email invitations will be sent to the address provided on the Official Bidder's List. The Tender Opening Committee will conduct the evaluation of the tenders and Compliant tenders will be included in the summary of bids on the City's Tenders & Proposals website within 1 business day following the tender closing.

Timetable for Completion of the Work

Replace Section 2.2.10 with the following: "The Substantial Completion of the Work is ten(10) weeks from start of construction, but no later than October 15th, 2025".

Replace Section 4.2, Paragraph 4, with: "In the event that the City accepts its Tender, the undersigned Tenderer hereby agrees to Substantially Complete the Work ten(10) weeks from start of construction, but no later than October 15th, 2025."

Replace Section 5.1, paragraph 2(c) with: "The Contractor shall Substantially Complete the Work ten(10) weeks from start of construction, but no later than October 15th, 2025.

Section 3.1.32.11 – Combination Air Valve, Add "DeZurik APCO ASC Single Body Combination Valve" as approved equal.

Replace Section 3.1.32.15 – Level and Float Sensors, paragraph 6, with "Two (2) new float type level switches shall provide the signals for a high-water level (alarm) indication and for low water alarm and pump shutdown redundancy. Replace Section 3.1.02.18.10.2 – Electrical Heater, with "Stelpro WF1508W or approved equal."
