Q2. For APC, can you clarify how many buses have 2 doors and how many buses have 1 door?

Q3. Can you confirm Active Directory is currently used by SJT for user authentication?

A3. *SJT uses Microsoft Azure. SJT also uses the Microsoft authenticator app for multifactor authentication (MFA).*

Q5. Can the City further elaborate on the timeline for “shortlisting” and what the process between shortlisting and selection will look like?
