

City of Saint John Ethnocultural Small Grant Guidelines



<u>Disclaimer:</u> The purpose of this document is to serve as a summary of the Ethnocultural Small Grant Policy. Please review the Policy before submitting an application.

The City of Saint John **Ethnocultural Grant Program** was established to further the City's goal in becoming the most welcoming community in Canada. The program provides financial support in the form of small grants for the **establishment** or **support** of further development of an **ethnocultural community group** in Saint John. An ethnocultural organization is defined by the shared characteristics of the members of the group, specifically country of origin, or ancestry.

This Grant opportunity started with a successful pilot program in 2021/22. In 2023, the Saint John Common Council ratified this particular granting initiative to be an annual Ethnocultural Small Grant Program.

The grants are obtained on a 'first come, first-served basis. The applications are reviewed on an ongoing schedule meaning that from the opening day, applications can be accepted, and grants will be allocated as the applications are reviewed depending on the cycles that they fall.

Applications will be eligible to be received continually and granted as they are moved through the distribution cycle from January – April and May— August each year.

Awarding of grants will be one-time opportunities with them being awarded once the application is received, reviewed and approved by the Grant Jury. A Terms and Conditions of Funding document is signed by the applicant at the time of disbursal of funds.

Options of ethnocultural small grants are:

Ethnocultural Establishment Grant:

Funding up to \$1000 or In-Kind Support

This is designed for new groups in their first year of applying for Ethnocultural Grant funds and is aimed to groups that want to become formally established and incorporated as a not-for profit.



Types of eligible Support:

Name Search; Not-for-profit-incorporation fees; form filling guidance; completing terms or reference; establishing a board of directors; room rentals for initial meetings including small catering expenses; setting up a bank account; purchasing cheques and necessary office materials. The allotment is capped at up to \$1000 CAD.

* Once approved, the funds must be billed directly to the Growth Department and will not be allocated in cheque or funds.

Ethnocultural Awareness Grant:

Funding up to \$2500



This is designed for groups that are already formally established as a not-for-profit and want to promote their association or help potential new members find them.

Types of eligible Support:

Creation of a website; web hosting fees; logo design, tradeshow booth materials (pop-upstands/tablecloth), branded apparel, support for creating social media platforms, promotion, or advertising expenses to attract new members and build brand awareness.





Expenditure examples for Establishment Grant:

The following are examples of expenses and activities that **would be** *eligible* for funding:

- payment for incorporation
- to assist in cost of name search
- assistance in creating a terms of reference
- guidance on setting up a bank account
- purchasing cheques
- cost of domain name for professional email address
- costs associated with setting up social media pages
- setting up a group chat group (WhatsApp, We Chat)
- creation of a logo or design to represent the group
- branding, design, advertising and marketing materials
- purchase of national flag
- room rental fees for initial meetings
- purchasing office supplies for initial set-up

Expenditure examples for Awareness Grant:

The following are examples of expenses and activities that would be eligible for funding:

- creation of a group website and website development
- costs associated with promotion of social media pages
- setting up a group chat group (WhatsApp, We Chat)
- creation of a logo or design to represent the group
- branding, design, advertising, and marketing materials
- welcome or arrival signage
- purchase of national flag
- rental fees for select events or ceremonies (especially when the general public is invited to engage with your ethnocultural group) *please check on eligible options with staff*
- promotion/advertising expenses





Application Requirements:

- an application completed in full answering the main questions such as if your group is incorporated or not and identifying how much money your group is seeking.
- If incorporated already, document showing that the registration is active.
- include a document showing your budget and in-kind ability your group may have available already
- if you have previously received an Ethnocultural Grant, we require that you complete
 the Outcome Report <u>before</u> applying for a new grant or by January 31st. These
 Outcome Reports will be available to the public. You may find the Outcome Report

- submit your web application and additional documents via email to <u>newtosaintjohn@saintjohn.ca</u> or print out and submit paperwork via the ONE STOP customer service desk at the front entrance of City Hall on King Street (address listed at the bottom of the application).

Application Timeline:

Applicants can apply anytime between **1 January to August 31** when the process closes each year. Applicants can apply once per funding cycle and only apply to one type of City of Saint John Grant, so if applying to the Arts & Culture Grant, Community Grants, ProKids or Ethnocultural Grant – you must choose one.

The Ethnocultural Small Grant Jury will assess applications based on a merit matrix via a 'first come, first serve' basis and distribute grants to eligible applicants until the funding is exhausted. This will be a continual open application opportunity over the duration of the period between January and August, however the Grant Jury will only review applications at the end of cycle 1, in May and at the end of cycle 2, in September.
