Saint John Transit is seeking applications for customer-focused individuals interested in beginning their career at Saint John Transit as “Extra Board Bus Operators.” These entry level positions are guaranteed a minimum 20 hours per week. Working varied shifts including days, evenings, split and weekends is required. Training will be provided for applicants who meet the requirements below. Extra Board Bus Operators are eligible for membership in ATU (Amalgamated Transit Union) Local 1182.

About Saint John Transit

We provide safe, reliable public transit for residents and visitors in the City of Saint John, New Brunswick, located on the shores of the Bay of Fundy. Our service operates from the Saint John Transit Operations Centre at 55 McDonald Street, Saint John, NB. Our hours of operation are Monday-Friday 5:50 am – 11:55 pm, Saturday 6:20 am – 11:10 pm and Sunday 7:20 am – 7:10 pm.

About our Drivers

Our drivers are the front face of Saint John Transit. Customer service is a large part of their daily duties. They are courteous, communicate effectively with all passengers and respond to their needs while safely and efficiently operating our vehicles.

Our operators operate buses in high density traffic in all weather conditions. Operators must be attentive, have good judgment, safe driving habits, punctuality, and an ability to deal with a diverse customer base.

Operators collect appropriate fares, provide routing and schedule information, and monitor their passengers and other drivers. They also monitor vehicle performance, use transit technology, report maintenance and software issues, and fill out incident reports.

Requirements

- Criminal Record Check and Drivers Abstract
- Valid Canadian driver's license with a safe driving record (no more than 2 demerit points and no more than 1 at-fault accident)
- Grade 12 or equivalent
- Three (3) years of experience working in a service occupation dealing directly with customers



- Five (5) years of recent driving experience, preferably with experience in the operation of a commercial vehicle in excess of one ton
- Be comfortable using technology
- A Class 2 NB Drivers License with air endorsement is not a requirement as successful applicants will be provided the necessary training
- The ability to communicate in both official languages is considered an asset, as is proficiency in any other language
