- Planning Advisory Committee Variances
- Similar or Compatible Use
- Conditional Use
- Non-Conforming Use
- Subdivision Applications that involve the dedication of Land for Public Purpose or the creation of lots not fronting onto a public street

Public Hearings will no longer be held at PAC for the following application types:

- Amendments to the Municipal Plan
- Amendments to Secondary Plans
- Amendments to the Zoning By-Law, including Rezonings
- Amendments to Section 59 Conditions
- Subdivisions that Create a New Public Street
- Land for Public Purpose Release
