

## REQUIRED DOCUMENTATION FOR RESIDENTIAL PARKING PERMITS

A Residential Zone Parking Permit makes it easier for residents to find curbside parking on their own street by exempting permit holders from the two-hour parking limit that's otherwise enforced. The permit does not guarantee a parking space, but it frees up spaces so more are available for

those with permits.

Permit holders are exempt from the 2-hour limit—but are still subject to all other traffic regulations such as parking meter regulations and signs prohibiting or restricting parking, stopping, or standing.

Residential permits expire on April 30<sup>th</sup> each year.

The annual cost of a residential permit is \$60.00 including HST.

Temporary Residential passes are available for \$14/week for up to 2 weeks to allow time for the applicant to provide the proper documentation for the annual Residential permit.



You must present the following documentation in order to obtain a residential parking permit:

### 1. REGISTRATION (INDICATING CURRENT UPTOWN ADDRESS); and

• If the information on the registration cannot be changed, please also provide the insurance policy showing the corresponding policy information and the applicant named as an insured driver on the vehicle.

## 2. PROOF OF RECENT RESIDENCY IN THE UPTOWN AREA – (ONLY ONE IS REQUIRED); and

This documentation must be presented upon renewal each year.

- Copy of lease or rent receipt indicating address
- Current utility bill for service at that address (power, telephone, cable etc.)
- Other current business type mail (bank or credit card statement etc.)
- Signed letter from landlord confirming residency.

### 3. NO OUSTANDING PARKING TICKETS

All parking tickets must be paid in full.



## **Alternate-Side Restrictions**

## How does alternate-side parking work?

- From the 1st to the 15th day of each month, parking is allowed on the odd-numbered side of the street.
- From the 16th to the last day of each month, parking is allowed on the even-numbered side of the street.
- Changeover from one side of the street to the other takes place from 6:01 p.m. to 12:00 a.m. on the 15th day and the last day of each month.

#### South Central Peninsula

In an effort to better manage street cleaning, snow removal and street maintenance in the South/Central Peninsula, alternate side parking is in effect year-round, January 1 to December 31.

Schedule G & G-1 of the Saint John Traffic By-law lists the streets and street sections where alternate-side parking is in effect.

### Areas outside of the South Central Peninsula

In specific areas located North, East and West of the City, alternate side parking is in effect from December 1 to May 31.


Schedule G-2 of the Saint John Traffic By-law lists the streets and street sections where alternate-side parking is in effect during this time.

## King Street East – Alternate-side parking

For the blocks of King Street East between Carmarthen and Wentworth Streets and Pitt and Crown Streets, alternate-side parking is in effect from December 1 to March 31. Parking is permitted on both sides of the street of these two blocks from April 1 to November 30.




## Zone A









# REQUIRED DOCUMENTS FOR TEMPORARY RESIDENTIAL PARKING PERMITS

The Parking Department allows uptown residents to purchase temporary residential parking permits for their visitor (100km outside Saint John) or for new residents to the city to provide time to update vehicle registration prior to purchasing an annual residential pass.

The permits are \$12.17 per week **X** 15% tax = **Total \$14.00** For two weeks \$24.35 **X** 15% tax = **Total \$28.00** 

Temporary passes can be issued for the following for up to 2 weeks ONLY:

**Visitor:** If an uptown resident has a visitor **(100km outside Saint John),** the <u>visitor</u> may purchase a temporary residential pass. The visitor must show confirmation of their address or the <u>resident</u> may purchase the temporary pass for visitor.

Proof of the visitors address must be shown (ie: registration/drivers licence)

**Rentals:** If a residential permit holder requires a rental, they may <u>purchase</u> a temporary residential pass by providing proof of a rental agreement <u>and</u> proof of residency.

## Options for those that don't qualify for a temporary permit:

- If parking in a residential area the individual may park for free for up to two hours, and move their vehicle in accordance with the Traffic By-law (to a new street) every two hours;
- Pay for parking in areas that have meters that allow parking up to 10 hours;
- Purchase a monthly parking pass (off street lot or parking garage);
- Park for free overnight in any of our off-street City lots.
